

## **Comparison of CFAAC Donor Advised Funds vs. Private Foundations**

Considerations	<b>CFAAC Donor Advised Funds</b>	<b>Private Foundations</b>
Ease of Establishment & Tax Exempt Status	<ul> <li>Fund is established immediately with a simple agreement and covered by CFAAC's tax exempt status</li> </ul>	<ul> <li>Corporation or trust required; IRS application for tax exempt status may take 6+ months to process</li> </ul>
Start Up Costs	• One time fee of \$250	• Generally \$5,000-\$10,000
Assets Required	• \$10,000 minimum	• \$8+ million to be cost-effective
Investment of Assets	<ul> <li>CFAAC Asset Management Committee oversees investment policy</li> </ul>	• PF must establish policies, select investments and pay associated fees
Tax Deductions for Cash Gifts	• Up to 60% of Adjusted Gross Income	• Up to 30% of Adjusted Gross Income
Tax Deductions for Appreciated Publicly-Traded Securities Gifts	<ul> <li>Full Market Value up to 30% of Adjusted Gross Income</li> </ul>	<ul> <li>Full Market Value up to 20% of Adjusted Gross Income</li> </ul>
Excise Tax on Investment Income	No Excise Tax	• 2% Excise Tax
Payout Requirements	• None, at donor discretion	• Annual minimum payout of 5%
Annual Tax Filings & Returns	• Filed by CFAAC	<ul> <li>Must be filed by PF with required detailed reporting schedules</li> </ul>
General Administration	<ul> <li>CFAAC modest administrative fee is withdrawn biannually</li> </ul>	<ul> <li>Trustees must perform, contract, or hire staff</li> </ul>
Grantmaking Control	<ul> <li>Donor may recommend grants to any Qualified 501(c)(3); Grants approved by the CFAAC Board</li> </ul>	<ul> <li>Trustee appointed Board controls grantmaking to IRS Qualified Charities</li> </ul>
Grant Administration	<ul> <li>CFAAC staff verifies IRS charity status, writes checks and distributes grants (in the fund name or anonymously) with letters or agreements, and confirms distribution</li> </ul>	<ul> <li>Trustees must perform, contract, or hire staff</li> </ul>
Grantmaking Support	<ul> <li>CFAAC monitors and researches local nonprofits and offers a wealth of expertise on local need and nonprofits upon request</li> </ul>	<ul> <li>Trustees must perform, contract, or hire staff</li> </ul>
Privacy	• Yes, fund size/grants are confidential	• No, IRS 990-PF public record
Liability & Risk Insurance	• Provided by CFAAC at no cost to donor	• Must be purchased by PF
